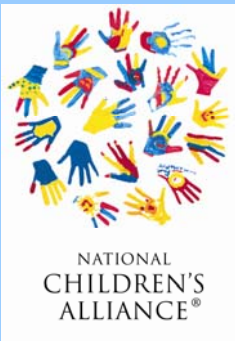




Ginnie's House

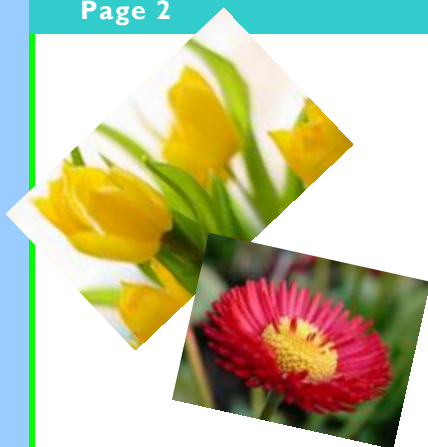
Safelite Glass Hosts a Classic Car Show Fundraiser!

Sussex County Farm and Horse Show 2009!

In April the State Fair, Sussex County Farm and Horse Show, presented a generous donation to Ginnie's House.

Ginnie's House played an active role in this year's fair. We won a Blue Ribbon for best display in the Sussex County Building. Ginnie's House volunteers also raised over \$100 dollars in donations from fair goers who enjoyed our display and support our cause. Our display table in the Sussex County building was run with the help of over 20 volunteers. An equal number of people provided information so that they could sign up to become volunteers for Ginnie's House in the future.

We also participated in the NORWESCAP sponsored Children's Day at the fair by providing interactive activities for over 100 children who came to our booth.



April is Child Abuse Prevention Month!

The Sussex County Freeholders offered a proclamation stating that April was Child Abuse Prevention Month. Our program director Scott MacLean attended the meeting to accept the proclamation on behalf of the children that are served at Ginnie's House. Blue ribbons have been used to symbolize child abuse prevention and awareness. Ginnie's House Volunteer Coordinator Helen Malkin, placed blue ribbons outside Ginnie's House and around the green in Newton.





Ginnie's House CAC offers programs and services as a result of the collaboration of community agencies committed to an educated and sensitive approach to the investigation, prosecution and treatment of child abuse.

We are grateful to our partnering agencies, and especially to the professionals who work tirelessly day and night to assist children and families who have been devastated by abuse.

OVERVIEW OF PROGRAMS

A. INTERVIEW FACILITY:

Provision of a safe environment, both physically and emotionally, for the investigative interview of the allegation of child criminal abuse (physical and/or sexual abuse).

B. CRISIS INTERVENTION:

Crisis intervention is available to non-offending caregivers and children (limited) on site. On-call list of therapists are available for child crisis response.

C. REFERRALS:

On-site, immediate assistance to non-offending family members with referrals to on and off site services. Often, the MDT Coordinator can complete the appropriate paperwork during the time of the forensic interview, thereby reducing the trauma of repetition to the family.

D. MEDICAL EVALUATION:

Experienced, on-site medical examination with Pediatrician and Sexual Assault Nurse Examiner, using state-of-the art technology.

E. PROVISION OF FACILITY FOR ON -SITE THERAPY:

On-site specialized child therapy provided by the Center for the Protection of Children (CPC), a division of Saint Clare's Behavioral Health.

F. PROVISION OF FAMILY ADVOCACY:

On-site psycho-education provide by an LSW, Licensed Social Worker, to non-offending caregivers, in an individual or a group setting.

G. CASE COORDINATION/CASE MANAGEMENT:

MDT Coordinator provides neutral on-site case coordination of open cases through conclusion of the criminal justice process.

H. CAMP PROGRAM:

Funding for summer camp experience (day camp or overnight camp, as recommended by an individual therapist) to current or immediate past clients and siblings.

I. HIGH TECH CRIMES UNIT:

Partnering with Sussex County High Tech Crimes Unit to provide community educational resources regarding the prevention of internet crimes against children.

J. PROFESSIONAL TRAINING AND EDUCATION:

Provision of timely and appropriate current professional training and education.

K. COMMUNITY EDUCATION:

A community prevention program through education and awareness.

L. VOLUNTEER PROGRAM:

Following background checks, reference screening, and orientation, volunteers are asked to assist with daily tasks at the center or in the community. We especially need our volunteers to help with the NJ State Fair and during the holidays!

Volunteer direct contact with clients is limited and confidentiality is always key.
